To be considered for an Economic Injury Disaster Loan related to COVID-19, there is a specific electronic application that should be used. The prompts can be filled out entirely online, and without paper forms or signatures (at

https://covid19relief.sba.gov/#/)

Application information that isn't submitted using <u>https://covid19relief.sba.gov/#/</u> is not expected to be paid the emergency advance/grant and may experience processing delays.

### IT IS IMPORTANT THAT APPLICANTS GET THEIR "PLACE IN LINE" BY SUBMITTING THIS AND ONLY THIS INFORMATION.

After the SBA reviews and processes the application, they may request some additional information prior to disbursement of the loan funds.

Some of this additionally requested information might be information normally collected on forms that are used as part of the NON-COVID-19 EIDL Program. It's possible the SBA can issue funding with no additional information beyond this.
